- 1989-1995 Santee School District Administrator/Supervisor for The Project SAFE Program-Supervised 10 separate school sites and staff in administrative office. This is the Before and After School Day Care program for Santee School District. Supervised approximately 1000-1200 children daily, (within the 10 school sites). Managed, trained, motivated and hired, 100-130 employees on a daily basis. (Hired and trained over 100 employees in a 6 year period) Supervised and administrated \$1.4 million dollar annual budget. Created training programs, organized and ran staff meetings, documented problems with difficult staff members, worked with parents, teachers, children and administration as well as the community members to create an effective and powerful program that operated from 6:30 a.m.,until 6:00 p.m. Worked with financial administration, human resources/personnel, custodians and maintenance departments, the kitchen staff, the superintendent and assistant superintendents to maintain positive

relationships, as well as organized and effective management of the program. Organized field trips for over 400 children during the summer, attended field trips and organized transportation, and fund raisers to offset school budget crisis. Moved 10 school sites into 2 sites for summertime programs. Trained other child care/preschool teaches at international and local conferences with strategies to be more effective as a teacher or administrator. Worked with children and parents as well as teacher and staff when a child has special issues that required my expertise and intervention. Planned and implemented the 12 month program including summer time full day programs, pre-K-8th grade. Trained staff on the following topics team First Aid and CPR certification, team building, positive discipline, safety, effective communication skills with a difficult parent or child, working with divorcing and conflictual parents. Organized and facilitated a monthly Parent Advisory Meeting for parent representatives of all 10 schools. Addressed the school board regarding growth and financial issues. Spoke at community events and participated in the community to create awareness of the program. Worked with parents to increase fees and had a strong relationship with parents involved in the program. Enjoyed my 6 years as the Project SAFE Supervisor.

- June 2009-present Launched online Interactive parent education program, High Conflict Intervention Courses for high conflict parents. International course has 325 lessons and 400-800 Powerpoints and audios as part of the courses. Parents in San Diego County are court ordered to attend the live courses or online courses. Courses are also ordered for conflictual coparents who are English speaking and live in Hong Kong. www.ParentsInConflict.com. When completed there will be approximately 30 online courses available for parents and professionals involved in conflictual coparenting.
- Feb 2010 to present The Big Ask Strategies Meet up and Mastermind- working weekly with business clients in a mastermind capacity to help them think bigger, ask bigger, aim bigger, achieve bigger and appreciate bigger. Approximately, 20-30 members participate weekly in the Big Ask Meet up.
- 1997- present Founder, Executive Director, Curriculum Writer & Facilitator of the live San Diego County High Conflict Intervention designed both a twelve week parent education program and an anger management parenting education program, geared to help parents end the conflict while protecting the children from further damage due to unnecessary litigation and arguing.

- 1995-present FamilyCare Resource Center- educational consultant, parent and professional educator for conflictual coparents - work with parents, grandparents and stepfamilies, judges, family law attorneys, mental health and teachers, and all other professionals involved in or with conflictual family/child sharing situations. I provide education and develop a working plan for professionals and family members to end the conflict between coparents. I teach parents how to stay close to their children, enhance self esteem, communicate more effectively with the other and focus their energy on effectively and positively parenting their children.
- 1997- present Train professionals through individual sessions, professional speaking and training programs as well as meet individually with family law attorneys and family court mediators, mental health professionals and other professionals working with conflictual child custody situations. Acted as a special master (working directly with all family members and professionals to calm the highest level of conflict in families down). Wrote reports for court professionals recommending strategies to end the conflict and protect the children. Worked with all family members involved in the highest level of conflict, helping them to learn new skills and techniques including, positive discipline, stress reduction, skills to move parents away from the fight toward becoming effective single parents, while the children thrive.
- 2002-present Real Estate Broker-Also work with traditional and blended families, seniors, singles and couples in real estate, specialized in families who were selling their homes due to trauma, divorce, death of a spouse and an illness of a family member. Also work with senior clients who were downsizing and relocating. Communicated with the professionals involved with the sale of these properties.
